## Pesticide Controversy Continues at Capitol

The fight over a proposal to ban the use of genetically-engineered lawn and turf seeds continues at the State Capitol. By a vote of 25-11, the Senate passed a bill to enact such a ban. The next day the House, however, overwhelmingly turned it down by a vote of 37-103. At this writing there are rumors that advocates will try once again for the ban by attaching it to related legislation. CNLA has argued that such decisions should be based on science and have the benefit of a full and detailed public hearing, something that has not happened this session on the issue. Time is running short as the 2014 session will adjourn at midnight on Wednesday, May 7.

recently announced an agreement that will allow Connecticut to utilize more than \$8 million in federal funds to keep farmland in agricultural production.

The agreement also will increase flexibility in the use of federal funds through the state's Farmland Preservation Program. More than 300 state farms have been protected under the program, including nearly 100 achieved with \$20 million in assistance from the federal USDA Natural Resources Conservation Service (NRCS) Farm and Ranchland Protection Program (FRPP). The announcement was made on Wednesday, April 9.

#### <u>Jobs Data Shows Positive</u> Trend

A new report by the state's Labor Department shows Connecticut added 4,900 jobs in March. According to the department, "March showed some solid signs of a return to previous job growth trends." The numbers mean the state has gained back 55 percent of the 119,000 jobs lost in the recession. Analysts say the state will need a good four or five months of job growth before the can see a real expansion is taking place.

#### <u>Producer Education and</u> Innovation

A working group of the Governor's Council for Agricultural Development is discussing a wide range of proposals to improve innovation by Connecticut's agriculture producers. Some of the ideas under consideration include increasing staff at the CT Agricultural Experiment Station and UCONN Cooperative

Extension to work more directly with producers and post-secondary educational institutions. The latter could permit more credit and non-credit courses relating to agriculture to be offered. The group is also discussing the state's program of tax incentives to

foster economically viable production. The recommendations will be considered by the full Council.

## A Horse is a Horse, Of Course, Of Course...

So said State Rep. Linda Gentile, in bringing out a bill in the House this week that reduces the liability of horse owners in civil lawsuits. The bill, H.B. 5044, passed the House. According to The Hartford Courant, the bill was prompted by a high-profile lawsuit where the state's Supreme Court ruled against the owners of a horse that had bitten a two-year-old child in 2006 at a garden center. The decision seemed to say horses are inherently dangerous animals. Gov. Malloy stepped in to offer the liability change since the ruling could have ramifications in other areas of agriculture. In a statement after the bill passed the Governor said: "Connecticut has a large population of horse owners and handlers, and the associated agriculture sector of our economy continues to grow, contributing \$3.5 billion annually in our state's economy and accounting for 28,000 jobs."

Elaine O'Brien who died of brain cancer while serving in office.
